**** Number of persons attending will be established two (2) weeks prior to the affair. Minimum deposit due at the time of contract signing is \$200.00. Hall rental and Open Bar (excluding amenities) must be paid in full two (2) weeks prior to the affair unless prior arrangements have been made. All beverages must be purchased from post (no outside beverages may be brought in)!**

Please note these conditions: Hall capacity limited to **200** persons. No glasses are allowed on the Patio. A 6% Maryland sales tax has been included where applicable. Renter of Hall must secure their own permits (i.e. one day liquor license, gathering and gaming permits). For member discounts the post member must take out the contract in his/her name and must attend the affair as the person responsible. Any other discount to be considered must be approved by the Home Operating Committee Chairman or Hall Rental Chairman and annotated on the contract.
